BOOTH STRUCTURES

The booth rental does **not** include booth structures, furniture, or technical equipment. Turnkey solutions for **4**, **6**, **and 9** m² booths can be requested when reserving a booth. For structures over **2.5 meters high** or those affecting the visibility of neighboring booths, prior approval from the event organizer is required. The booth rental **does not cover damages** caused to the property or furnishings. Exhibitors are responsible for any damages to rented furniture and structures.

PAYMENT TERMS

- The trade fair start-up fee is invoiced separately upon booth reservation.
- Booth rental is determined by the reserved square meter area and will be **invoiced at the beginning of 2026 before the event**.
- The trade fair start-up fee (also serving as a reservation fee) **is non-refundable** in case of cancellation.
- All prices are subject to the applicable VAT rate.

For booths reserved before **December 31, 2025**, the rental fee (per square meter) will be invoiced in **early January 2026**. The payment for booth space or advertising **must be made within 14 days** of receiving the invoice. **Late payment interest: 11%**.

CANCELLATION POLICY

- **Cancellations between September 1, 2025 December 31, 2025: 50%** of the exhibition fee based on the reserved square meters will be charged.
- Cancellations after January 1, 2026: 100% of the exhibition fee will be charged.

The **Vihreä Kirja 2026** exhibition catalog will include all exhibitors who have reserved their booths by the deadline. The catalog will be **distributed via targeted mail and to all Viherpäivät attendees**. The material submission schedule will be announced later.

EXHIBITOR ACCOMMODATION

Exhibitors are responsible for booking their own accommodations directly with hotels. The **Viherympäristöliitto** has reserved room quotas in various hotels for exhibitors. Accommodation details will be sent as an attachment with the **booth reservation confirmation**.

CHANGES & FORCE MAJEURE

The organizer is not responsible for delays or damages caused by the **cancellation or rescheduling** of the event due to force majeure. **Force majeure** includes, but is not limited to:

- Disruptions in general energy supply
- Fire or other incidents preventing the use of the event space
- Natural disasters
- War, rebellion, or epidemics that restrict free movement and gatherings

A force majeure event affecting a subcontractor of the organizer will also be considered a valid reason for exemption. The organizer reserves the right to make changes to these terms and conditions.
